

Dear BCS Families,

We would like to thank you for filling out our Parent Feedback Survey. Out of our kindergarten through 12<sup>th</sup> grade families, we had about 60% respond to the feedback survey. Though not a full representation, this response does give us a good idea of what is important to our community.

Following are a few highlights and attached is the full response data for each survey question.

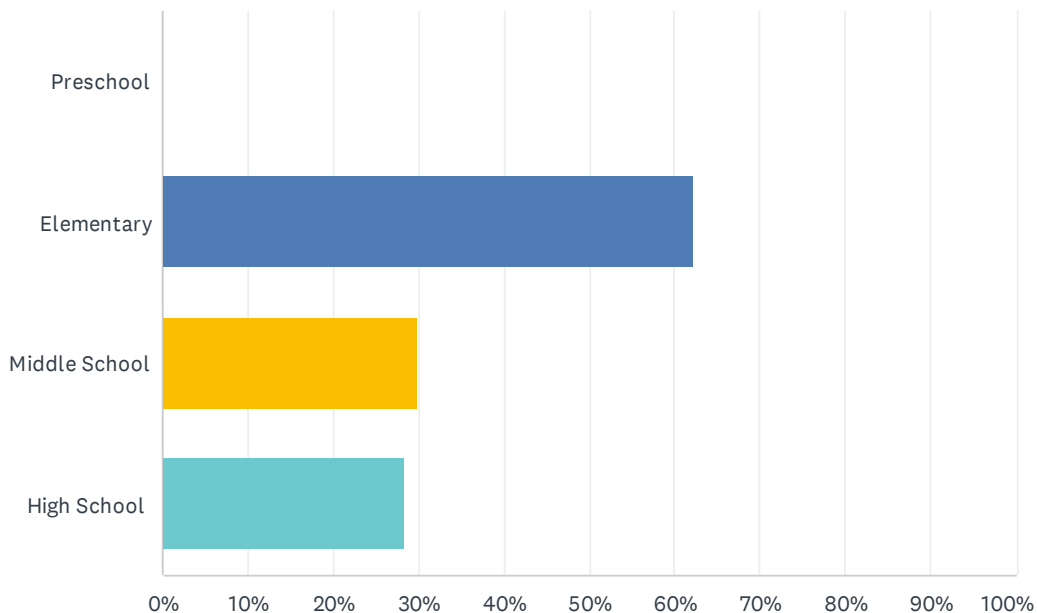
When asked about the vaccination status of children, 59.01% of the respondents stated that their children are not vaccinated at this time and would be requesting an exemption through BCS to not vaccinate their children. 25.27% of the respondents answered that their child(ren) has/have already received the COVID-19 vaccination, 9.54% said they intend to vaccinate their child(ren) for COVID-19 and 6.18% declined to state.

In regards to the question about future schooling options in the event that a personal belief exemption is not legally allowed, 40.88% of the respondents stated they would vaccinate their children and continue at BCS. 48.49% of the respondents stated they would unenroll their child(ren) from BCS and either enroll elsewhere or pursue homeschool or co-op options. 10.62% of the respondents declined to state.

We appreciate all the thoughtful responses to this survey. As a school we plan to use this data as we speak with our state representatives as well as incorporating this information into our future planning and preparations for the coming school year. May God continue to bless the ministry and mission of Bradshaw Christian School.

# Q1 Which campus do you have your children enrolled? Please select all that apply.

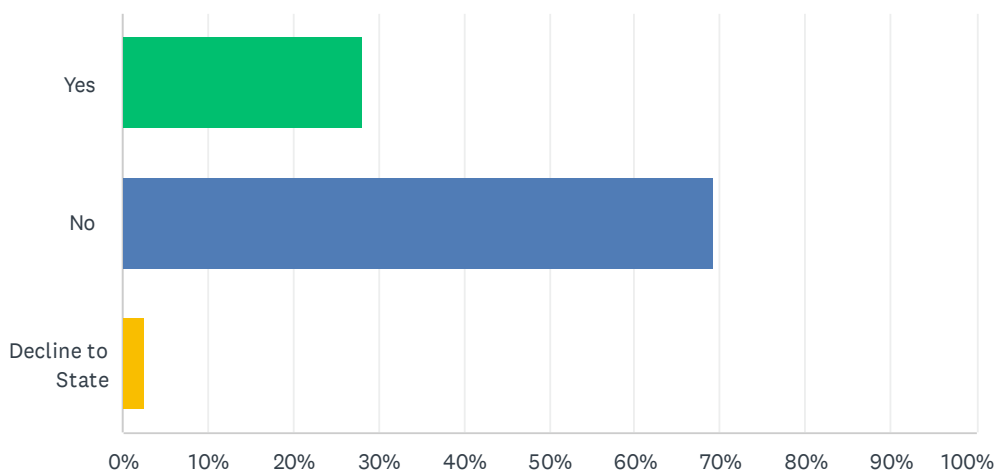

## Q2 Is/are your child(ren) currently vaccinated for COVID-19?

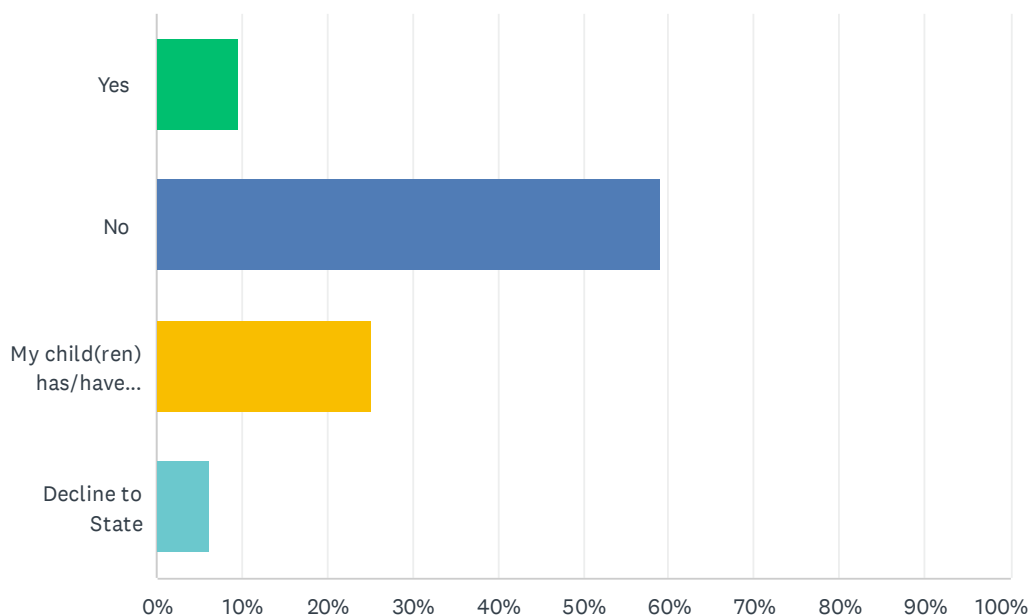

### Q3 Do you intend to vaccinate your child(ren) for COVID-19?

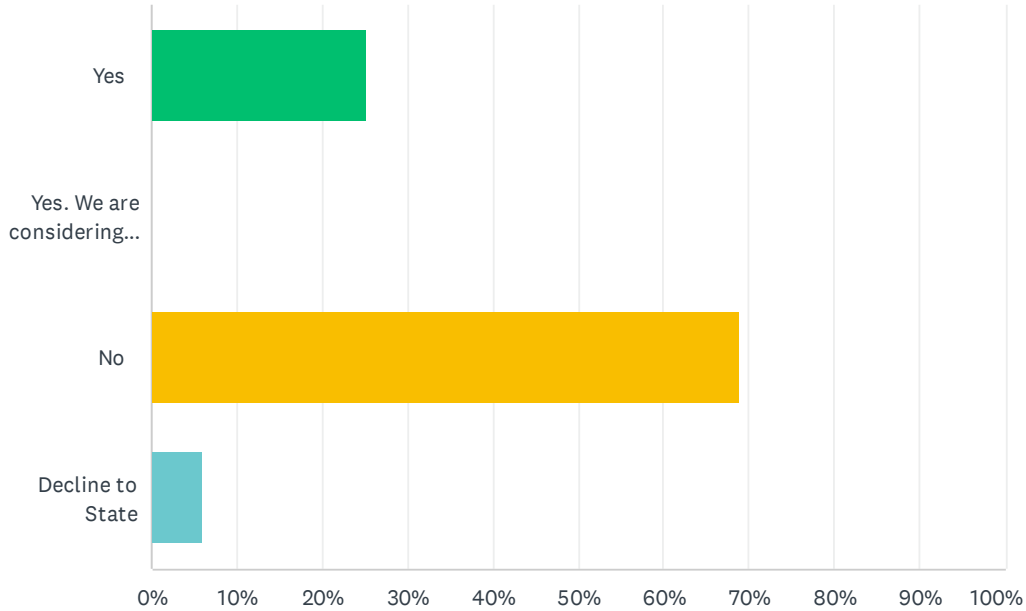

### Q4 Would you like BCS to comply with California’s emergency vaccine mandate for K-12 students if/when it goes into effect?

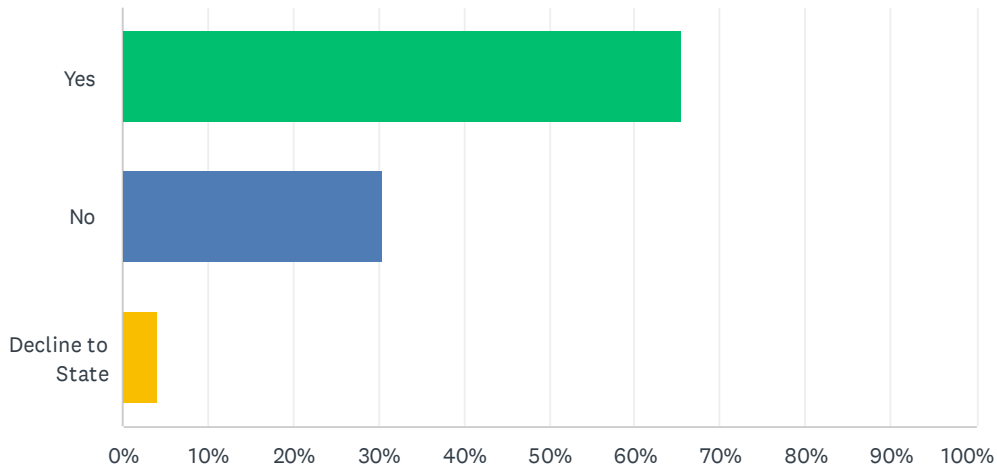

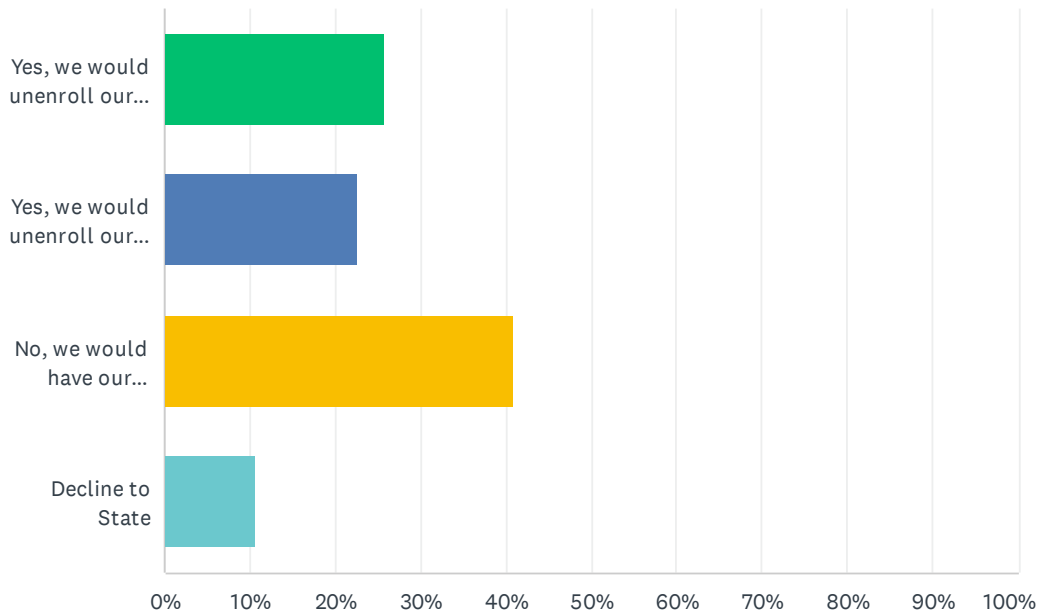

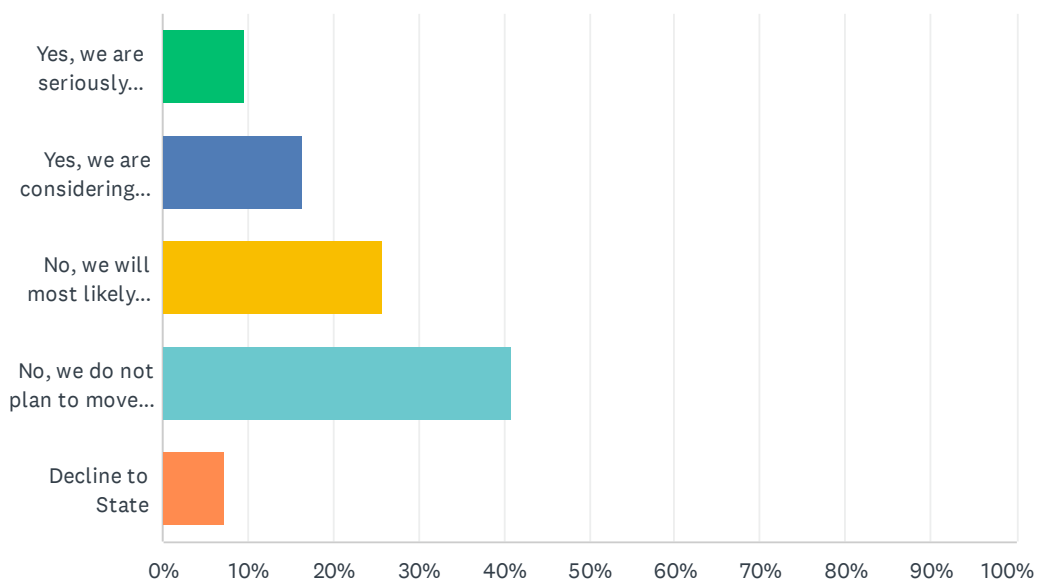

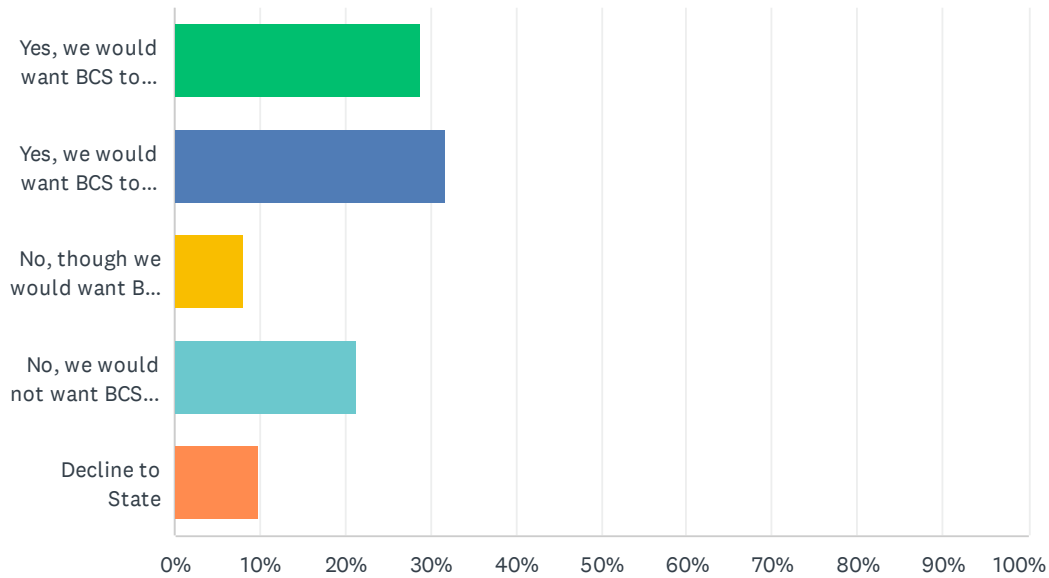
